

MENU OF SERVICES

BOARDING OPTIONS

BARN STALL (12x12) with run (12x24)	\$495/month
Includes three (3) feedings of hay daily (alfalfa, orchard, alfalfa), cleaning, watering, & up to eight (8) bags of bedding per month. Runs are half covered.	
BARN STALL (12x12) without run	\$450/month
Includes three (3) feedings of hay daily (alfalfa, orchard, alfalfa), cleaning, watering, and up to eight (8) bags of bedding per month.	
PIPE CORRAL (20x30)	\$385/month
Includes three (3) feedings of hay daily (alfalfa, orchard, alfalfa), cleaning, and watering. Bedding options available. Corrals are partially covered.	
COW PENS	\$315/month
Includes three (3) feedings of hay daily (alfalfa, orchard, alfalfa) and watering. Pens have small covered area for shade.	
PADDOCKS	\$285/month
Includes three (3) feedings of hay daily (alfalfa, orchard, alfalfa) and watering.	
WILD PASTURE	\$225/month
Horses have free-choice grazing; additional feed is provided at the discretion of the Ranch (up to 2 feedings of alfalfa per horse per day). Natural streams provide supplemental water source and pasture has plenty of trees for shade.

CURRENT BOARDERS WILL BE GIVEN THIRTY (30) DAYS NOTICE OF ANY CHANGES TO FEES. · A SECURITY DEPOSIT IS REQUIRED PRIOR TO THE ARRIVAL OF THE HORSE. · WE REQUIRE A THIRTY (30) DAY WRITTEN NOTICE IN ADVANCE OF THE DATE YOUR HORSE WILL BE LEAVING OR YOU WILL BE LEGALLY RESPONSIBLE FOR BOARD PAYMENTS UP TO 30 DAYS AFTER YOU LEAVE.
